Upgrade from Lexis Advance Quicklaw to Lexis+ Canada

As of February 1st 2025, Lexis+ Canada is replacing Lexis Advance Quicklaw and Practical Guidance.

- Legal Research (upgrade of Lexis Advance Quicklaw)
- Practical Guidance (now integrated within Lexis+ Canada)

Technical Requirements for Courthouse Library

Your service through LIRN include 2 types of connection :

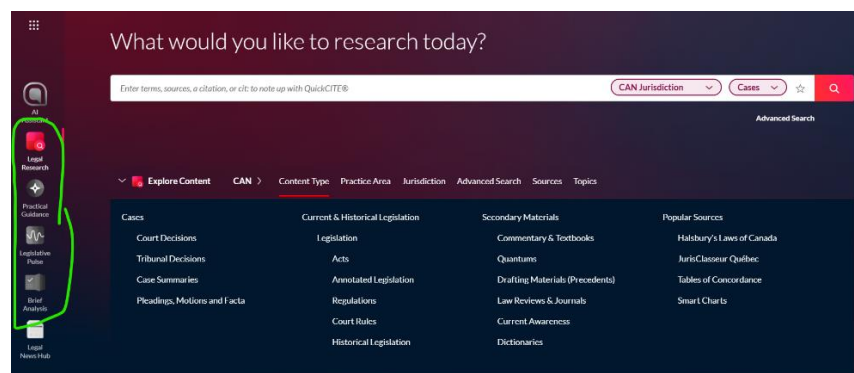
- Personal ID and password for the librarian
- IP authentication + MIP Profile for the terminal access in the physical library

We do not recommend setting up automated login with your personal access (ID and password) on the terminal access (any user from this terminal can reset your password and leave with your ID)

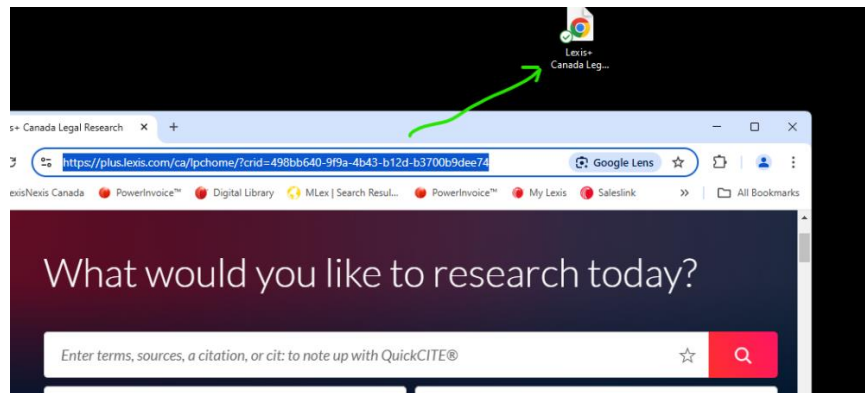
Any shortcut/favorite on the terminal access should be updated to the Lexis+ URL profile, replacing the LAQL URL

Lexis+ Canada On Terminal Access –Shortcut Set Up

- 1) **Remove** all shortcut
- 2) Clear cache of the browser and close all the windows
- 3) Click on the Lexis+ Canada Url provided or copy the Lexis+ Canada url on your browser
 - a. you should get automatically access to the Lexis+ Canada landing page
 - b. confirm you see the panel on the left



- 4) Select all the url and drag and drag and drop on the desktop (in the background).



Q/A for Terminal Access Set Up

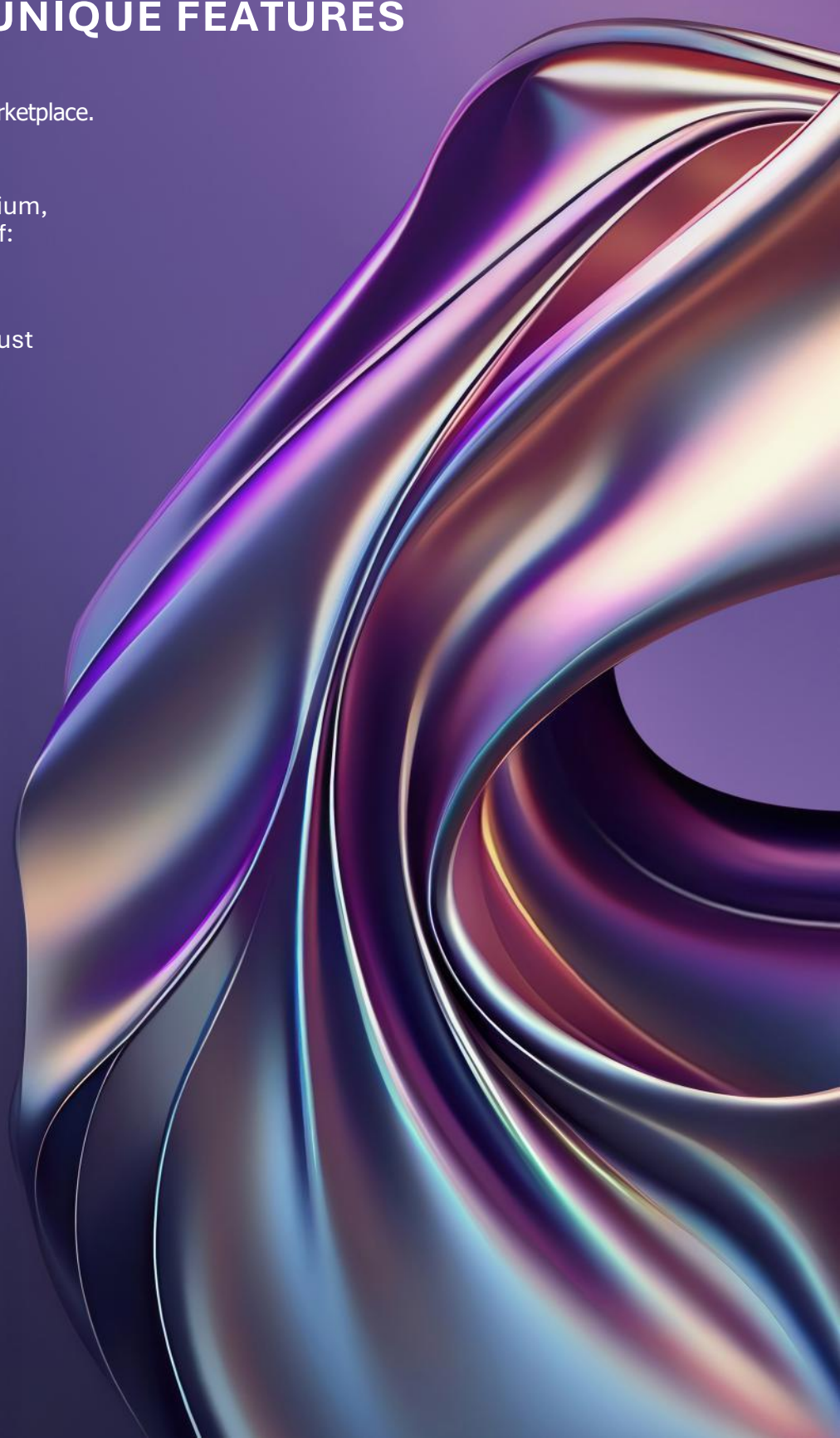

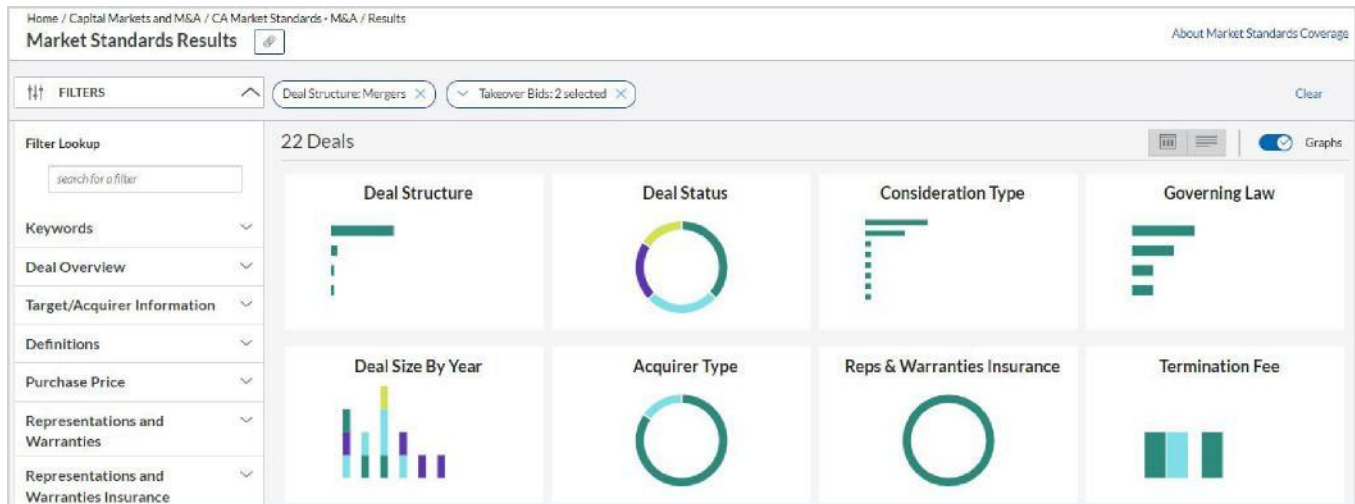
